Payment Plans

How Payment Plans Work

You choose your own payment dates. During our initial meeting, we'll confirm when each payment will be made. Grant-Writing work progresses based on payments received rather than preset calendar dates.

- 1. Once the deposit is paid, your project officially begins.
- 2. When the second payment is received, I'll complete and prepare your first draft.
- 3. When the final payment is received, I'll finalize your proposal and all related documents for delivery.
- 4. Payment plans are flexible, but the writing schedule is tied to your payment schedule.
